UNOLS Year in Review

The issue's / activities that we have addressed in the past year

- Safer Seas Act
 - Clarity from USCG regarding status of ARF vessels ("public vessel" issue)
 - Recognition that SSA applies to ARF
 - Plan developed with NSF to address Global & Ocean Class first, RCRV after delivery, & Regional/Coastal/Local will come later
 - UNOLS met with USCG HQ outlining ARF plans
 - UCSD / HiSeasNet Team contracting with Digigone for ship installations
 - Contract just issued vendor ordering equipment
- Global / Ocean Class Replacement
 - FIC focus on Global / Ocean class capacity
 - Kilo Moana Replacement / NOAA Class B Opportunity



UNOLS Year in Review Cont'd

- Marine Facilities Planning (MFP)
 - Continued refining of Cruise Planning Module being used by more operators, community becoming more & more proficient, looking to further optimize
 - Personnel Planning Module
 - Regular Cruise Planning Module meetings with operators & developer
 - Stefani Martynenko MFP Customer Service Point of Contact
 - Developing Project Support Plan
- Science Requirements for future U.S. Coast Guard Arctic Icebreaker(s)
 - AMRCC established
 - Initial workshop 14-15 November in Seattle
 - Upcoming community meetings
 NOTE: USCG has obtained I/B Aiviq
- Ship Scheduling
 - Continued Bi-Weekly meetings for Global/Ocean Class ship schedulers
 - Published most 2025 ship schedules in September
 - Moving Global/Ocean class scheduling timeline forward for 2026 –
 publish in July 2025
 - Still dealing with cruise deferral crewing & mechanical issue impacts

UNOLS Year in Review Cont'd

- Build America, Buy America (BABA) Act
 - NSF Determination of applicability does not apply to ARF!!
 - Ret. UCSD Capt. Eric Buck completed valuable research, interaction with UNOLS ship operators, discussion with NSF personnel, etc. to help others understand the impacts of BABAA on ARF ship operators
- MOSA Support
 - Capt. Buck now assisting NSF & Ship Operators with development, reporting and administration of MOSA budgets / funds
